#### Bid Conditions

1. This bidding is opened to staffs of Maldives Islamic Bank and External Parties.

4. The sealed envelope should be marked "BID ON MIB PROPERTY" and dropped in the Bid BOX officially placed for this purpose at the Administration Department, 4<sup>th</sup> floor, MIB Head Office.
5. The price schedule must provide a detailed cost breakdown for each item. Please bid for individual items or for the complete list of items, below listed. In case of discrepancy between unit price and total, the unit price shall prevail.
6. Bid Form is strictly accepted only at the MIB office – Administration Department until **14:00hrs of 28 February 2022.**
7. Bids will be opened on **28 February 2022 at 14.00 hrs.** MIB will make the announcement of the bidding results on **28 February 2022.**

8. The successful bidder will be required to pay the full bid amount in cash or account transfer within 3 working days.
9. After the payment is settled, the successful bidder could remove the asset from MIB Head Office latest by **3 March 2022**. The transportation arrangement to deliver the asset will be the on own account of the successful bidder without causing any damage to the surrounding property(s) Or, the successful bidder shall reimburse MIB for any damage sustained as a result of such removal.
10. If the items are not removed within 7 days, MIB has the right to discard the items.
11. MIB reserves the right to reject any or all the bids submitted without assigning any reason.
