## EVALUATION CRITERIA

All quotations will be evaluated based on the following criteria.

- **Price (90%)**

Price will be evaluated based on the lowest price proposed, i.e., the quotation with the lowest price will score the highest and maximum score of 90% while the remaining will be given scores relative to the lowest price.

- **Delivery (5%)**

Delivery period will be evaluated based on the lowest delivery period proposed, i.e., the quotation with the shortest delivery period for the design, production and installation will score the highest and maximum score of 5% while the remaining will be given scores relative to the shortest delivery period.

- **Experience (5%)**

Experience will be evaluated based on the stability of the business and completion of similar projects in the past. The following supporting documents must be submitted with the quotation.

- Company profile (with business registration)
- Reference letters of similar projects completed/ongoing
